MONALISA LIMOUSINE ~ PARENTAL CONSENT FORM

THE PARENT SIGNING DOES HEREBY AUTHORIZE THEIR MINOR (NAMED BELOW) ALONG WITH THE OTHER LISTED GUESTS TO BE TRANSPORTED BY MONALISA LIMOUSINE ON ___/___/___ . THIS INCLUDES, BUT IS NOT LIMITED TO, TRANSPORTATION TO AND/OR FROM ANY SCHOOL/ OR NON SCHOOL RELATED EVENT. THE PARENT SIGNING THIS FORM WILL BE RESPONSIBLE FOR THEIR MINOR CHILD INCLUDING BUT NOT LIMITED TO THEIR CHILD'S BEHAVIOR AND ACTIONS EVEN IF THE PARENT IS NOT PRESENT. THE PARENT UNDERSTANDS THAT EACH PERSON ENTERING THE LIMOUSINE THAT THEY HAVE BOOKED WILL BE THEIR PERSONAL RESPONSIBILITY. IN ANY CASE IF THEY BREAK OR DAMAGE ANYTHING OR VOMIT, THE CREDIT CARD ON FILE WILL BE CHARGED. ANY VOMIT FOUND INSIDE THE VEHICLE WILL INCUR A \$300.00 CLEANING CHARGE. EACH PERSON (MINOR OR NOT) ENTERING THE LIMOUSINE WILL ALSO BE REQUIRED TO SIGN A "LESLIE BILL" AT THE TIME OF PICKUP. THE LESLIE BILL IS A NO ALCOHOL STATEMENT FOR MINORS AND IS REQUIRED BY STATE LAW. CALIFORNIA STATE LAW PROHIBITS THE CONSUMPTION OF ALCOHOLIC BEVERAGES BY MINORS IN LIMOUSINES. THERE WILL BE NO ALCOHOLIC BEVERAGES ALLOWED IN LIMOUSINES AT ANY TIME DURING THE RENTAL PERIOD WHEN MINORS ARE PRESENT UNLESS A PARENT IS ALSO PRESENT. IF THE CHAUFFEUR FINDS THAT ALCOHOL OR ANY ILLEGAL DRUGS ARE BEING, OR HAVE BEEN CONSUMED BY MINORS IN THE LIMOUSINE DURING THE RENTAL, BY LAW THE CHAUFFEUR HAS THE AUTHORITY AND OBLIGATION TO RETURN THE PASSENGERS TO THE ORIGINAL PICK-UP ADDRESS. THE RENTAL SERVICE WILL THEN BE TERMINATED AND NO REFUND WILL BE MADE IN TOTAL OR IN PART WHATSOEVER. THE CONSUMPTION OF ANY ALCOHOLIC BEVERAGE IS UNLAWFUL WHEN CONSUMED BY A MINOR. THERE WILL BE NO ALCOHOLIC BEVERAGES TRANSPORTED INSIDE THE VEHICLE. ALSO NO ALCOHOLIC BEVERAGES WILL BE CARRIED IN THE TRUNK OR ANY OTHER LOCKED COMPARTMENT OF THE VEHICLE. THIS RULE SHALL APPLY TO ANY AND ALL OTHER ILLEGAL SUBSTANCES. IF AT ANY TIME, ANY OF THE PASSENGERS ARE FOUND TO HAVE IN THEIR POSSESSION, OR HAVE BEEN AT ANY TIME DURING THE COURSE OF SERVICE, CONSUMING ANY ALCOHOL OR OTHER ILLEGAL SUBSTANCE, THE SERVICE SHALL BE TERMINATED. ALL MONEY SHALL BE FORFEITED AND A PARENT SHALL BE NOTIFIED. THE DRIVER HAS THE OPTION OF RETURNING TO THE POINT OF PICK UP OR ENDING SERVICE AT THE POINT OF INFRACTION DEPENDING UPON THE BEHAVIOR OF THE PASSENGERS. THE DRIVER SHALL ALSO HAVE THE RIGHT TO EXAMINE ALL BAGS OR PARCELS TO BE PLACED IN THE VEHICLE TO DETERMINE IF THEY CONTAIN ANY ILLEGAL SUBSTANCES. A SEPARATE
